Program Highlights: Day-by-Day

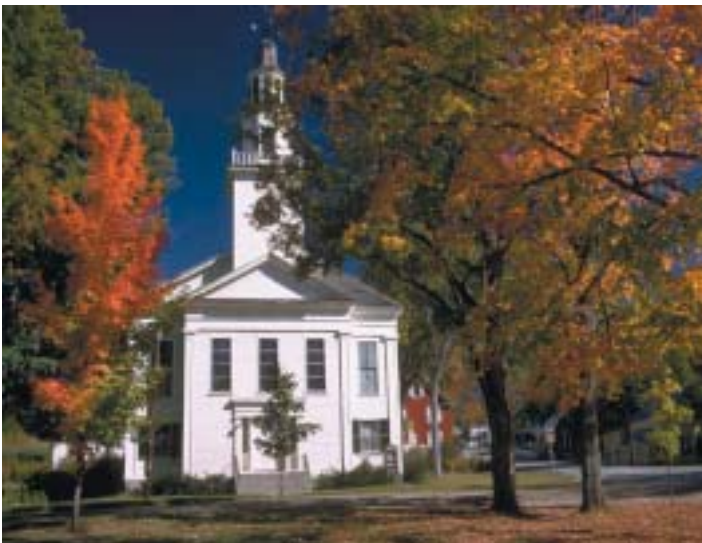
Day 5 - Thursday October 11, 2007 - Vermont Touring (B, D)

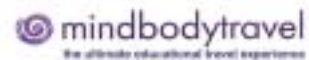

Travel Program Includes
